Makeup Prices:

Bride / Quinceañera: Airbrush: \$115 (Cash) / \$120 (Credit)
Traditional: \$100 (Cash) / \$105 (Credit)
(lashes, full size touch up lipstick, and blotting sheets included)

Clientele Party: Airbrush: \$80 (Cash) / \$85 (Credit)
Traditional: \$65 (Cash) / \$70 (Credit)
(lashes included)

Flower Girl:
(Age 8 and Under) Complimentary (blush, shimmer, and gloss included)

Hair Prices:

Bride / Quinceañera: \$115 (Cash) / \$120 (Credit)

Clientele Party: \$75 (Cash) / \$80 (Credit)
(Updo, Half Up Half Down, Blow-out Style, Curls / Waves, etc.)

All: Blow Dry*: \$35 (Cash) / \$40 (Credit)
*Can **ONLY** be added in addition to Hair Style

Pricing:

1. All of the following are considered Cash; Cash, Check, Venmo, and Zelle.
2. Credit Price applies if you have to Swipe, Tap, or Insert a Card to pay.

Wait Time Policy:

If the scheduled service start time begins later than that which was agreed upon and thereby runs over the scheduled end time, you may be charged an additional fee as this may compromise a later event on the same scheduled day. In this event, an additional \$50 will be charged for every hour over the scheduled end time.

Travel Fees:

A travel fee of \$0.58 per mile (round trip) applies to any address outside 25-mile radius from the zip code 75075 (Plano, Texas) for each artist.

Valet Parking:

If this is the only option available at your venue or that which is most easily accessible for the artists (within reason), fees for the service will be charged to the applicable party's room. Any other necessary parking charges will be the responsibility of the client.

Retainer:

A non-refundable retainer of \$100 is required along with signed agreement to reserve service. It must be either mailed with signed agreement or given to artist at the time of trial.

Contracted Date:

You may cancel this agreement at any time up to 30 days before the date of service and only lose retainer fee. Any time between 30 days and 48 hours of the date of service, a

50% refund will be applicable. Within 48 hours of the date of service, you will be charged 100% of the quoted rate. If an unexpected emergency should occur that prevents the artist from providing services on the agreed upon date of service, a replacement artist will be notified, if possible. However, if one is not available your retainer will be refunded.

Payment:

Trial and/or Retainer: Cash, Check, Venmo, Zelle, or Credit

Remaining Balance:

Must be paid no later than 14 days prior to event date or a \$50 late fee will be applied to the remaining balance. Can be paid by cash, check, or credit card from **one person only** i.e. bride, quinceañera, parents, or that to which whom is responsible for payment. I do not send individual invoices nor accept payment from each member of clientele party ahead of time. Client is responsible for collecting payment from her clientele party prior to the 14 days and then mailing the check or paying cash or credit 2 weeks prior.

Bridezilla Clause:

Subtitle aside this applies to **every** person in the clientele party and their family and/or guest. All of our clients are treated with the utmost respect and we ask that our clients, their party, family, and guest do the same. Unfortunately, on a few occasions there is that one person who goes out of their way to verbally or physically abuse our makeup/hair professionals. **At no time and under no circumstances whatsoever shall we tolerate; abusive, violent, destructive, menacing, or harassing behavior from the client or anyone acting on behalf of the client.** If such behavior does occur, we will quietly and respectfully inform the client and/or members to handle the situation. However, if the abusive behavior does not stop, we will consider it a breach of contract, and remove ourselves from the premises immediately without providing any further services and all remaining fees will be **due immediately** and, on the spot, regardless of further services not commenced and without any refund of monies paid.

Liability Clause:

I understand that the makeup/hair artist is not responsible for any liability incurred as a result of my participation in the hair or makeup application(s) of my clientele party, including medical expenses due to any allergic reaction, sickness, or injury as a result.
